

RESOLUTION 40-2010

A Resolution Relating to the Intention to Create RID-M 11-01 for the purposes of Maintenance within the Virginia City Ranches near Ennis, Montana

A RESOLUTION FOR THE MADISON COUNTY COMMISSIONERS DECLARING IT TO BE THE INTENTION OF THE BOARD OF COUNTY COMMISSIONERS OF MADISON COUNTY, MONTANA, TO CREATE A RURAL IMPROVEMENT DISTRICT FOR MAINTENANCE NO. 11-01 FOR THE PURPOSE OF MAINTAINING CERTAIN ROADS WITHIN THE VIRGINIA CITY RANCHES SUBDIVISION AND SKY VALLEY RANCHES FOR THE BENEFIT OF CERTAIN PROPERTIES IN MADISON COUNTY, MONTANA.

BE IT RESOLVED by the Board of County Commissioners of Madison County, Montana, as follows:

Section 1 – District Number

The Rural Improvement District for Maintenance, if the same shall be created and established, shall be known as Rural Improvement District for Maintenance No. 11-01 of the County of Madison, Montana.

Section 2 – District Boundary

The boundary of RID-M 11-01 will be created to include 293 lots, tracts and parcels more particularly described in Exhibit B, which by reference is made part of this document.

The roads to be included for maintenance are Badger Road (0.81 miles), Cottontail Run (0.39 miles), Deer Lane (0.67 miles), Mylane Road (0.84 miles), North Bluebird Lane (0.49 miles), Noack Road (0.59 miles), Preachers Lane (0.12 miles), Pyramid Lane (0.26 miles), South Bluebird Lane (0.36 miles), Tendoy Way (1.00 miles), Tobe Road (1.45 miles), Two Bumps Loop East (1.20 miles), Two Bumps Loop West (0.45 miles), Two Bumps Road (2.95 miles), Two Springs Road (0.77 miles), and West Canyon Road (0.16 miles). Refer to Exhibit A for a graphical depiction of the district boundary and maintained sections of roads.

Section 3 – General Character of Improvements

RID-M 11-01 is intended to provide maintenance for approximately 12.5 miles of gravel roads. The maintenance funds collected will be used for road maintenance, snow-plowing, weed control, road signs and incidental expenses as defined in MCA 7-12-2101 (7).

Section 4 – Engineer

Gaston Engineering & Surveying, P.C. will be the Engineer in charge for this project. The maintenance district will be setup to collect \$100 annually from each of the 293 total lots, tracts or parcels within the RID-M, creating an annual revenue of \$29,300. This amount is not intended to be sufficient to maintain all 12.5 miles of road every year, but instead a program will be implemented to maintain priority roads first and lesser priority roads in years to come. It is intended that all 12.5 miles of road will be substantially maintained within the first 5 years of implementing this RID-M.

Section 5 – Assessment Method

The RID-M will collect assessments per MCA 7-12-2151 (1) (d). The annual assessment per lot, tract or parcel shall be \$100, which is subject to future change by the Board of County Commissioners. See Exhibit C for ownership information for the assessed lots, tracts & parcels.

Section 6 – Public Hearing; Protests

At any time within 30 days after the date of the first publication of the notice of the passage of the resolution of intention, any owner of property liable to be assessed for the work proposed in the resolution may make written protest against the proposed work or against the creation or extension of the district to be assessed, or both. The protest must be in writing, identify the property in the district owned by the protestor, and except as provided in MCA 7-12-2141, be signed by all owners of the property. The protest must be delivered to the county clerk, who shall endorse on the protest document the date of its receipt by the county clerk. At the next regular meeting of the Board of County Commissioners after the expiration of the time within which protest may be made, the Board shall proceed to hear and pass upon all protests so made, and its decision shall be final and conclusive.


Section 7 – Notice of Passage of Resolution of Intention

The county clerk and recorder is hereby authorized and directed to publish or cause to be published a copy of a notice of the passage of this resolution in the Madisonian, a newspaper of general circulation in Madison County, Montana, on January 13, 2011 and January 20, 2011, in the form and manner prescribed by law, and to mail or cause to be mailed a copy of said notice to every person, firm, corporation, or the agent of such person, firm, or corporation having real property within the proposed Rural Improvement District for Maintenance No. 11-01 listed in his or her name upon the last completed assessment roll for state, county and school district taxes, at his or her last-known address, on or before the same day such notice is first published.

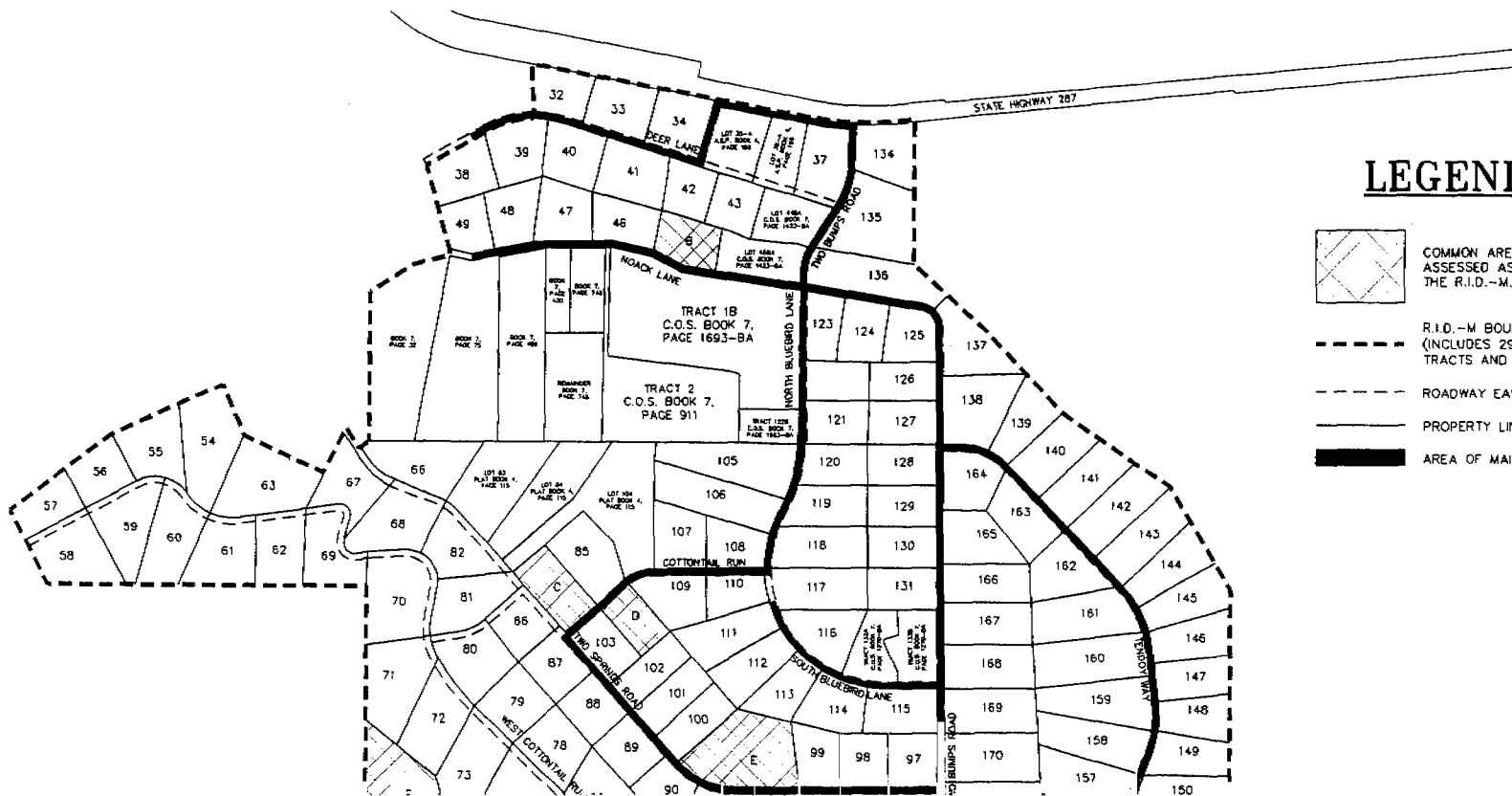
RURAL IMPROVEMENT DISTRICT FOR MAINTENANCE No. 11-01

"VIRGINIA CITY RANCHES" BOUNDARY EXHIBIT



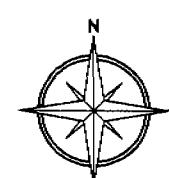
